

# From Hook to Table

Recipe: Fish Tacos

*Yellow Perch Tacos in Anticipation of the February Spawn*

## **Ingredients:**

2lbs Yellow Perch Filets  
Louisiana Cajun Seasoning  
2 Tablespoons Vegetable oil  
8-10 Small Corn Tortillas

## **Taco Sauce:**

½ Cup Sour Cream  
1/3 Cup Mayo  
1 Teaspoon Garlic Powder  
1 Teaspoon Sriracha Sauce  
1 Lime Juiced  
1 Pinch of Salt

## **Toppings:**

Shredded Red cabbage  
Fresh Cilantro  
Avocado  
Red Onion Chopped  
Lime Wedges



## **Directions:**

1. Rub the Louisiana Cajun Seasoning on both sides of the Perch filets and set aside.
2. In a large skillet heat the vegetable oil make sure the bottom of skillet is lightly covered. Add the Perch and cook 2 minutes per side.
3. Meanwhile combine Taco Sauce ingredients in a small bowl and whisk.
4. To assemble the Tacos, place 4 oz. of Perch in each tortilla. Top with Cabbage, Onion, Avocado, Cilantro, Taco Sauce and Lime Juice.
5. Serve immediately with your favorite cold beverage.

## VIRGINIA GENERAL ASSEMBLY HB 1612 IS OF INTEREST TO ANGLERS

One Bill currently being considered by the General Assembly of direct interest to the angler is (House Bill) HB1612. Here is some information from HB1612.

§ 29.1-113. Admittance, parking, and use at certain Department-owned facilities or Department-leased land; civil penalty.

A. No person shall make use of, gain admittance to, or attempt to use or gain admittance to those certain Department-owned facilities where the Department charges a fee established by the Board pursuant to § 29.1-103, unless the person pays such fee. However, such fee shall not apply to (i) any person holding a valid hunting, trapping, or fishing permit, or a current certificate of boat registration, issued by the Department, ; or (ii) ~~persons~~ *any person* 16 years of age or younger, or (iii) ~~the use of Department-owned boat ramps.~~

The chief patron is Hyland F. "Buddy" Fowler, Jr. and, at this writing, the Bill has been referred to the House Committee on Agriculture, Chesapeake and Natural Resources.

## **THINGS OF INTEREST TO THE ANGLER**

### **MODERN FISH ACT SIGNED INTO LAW, BOOSTING**

#### **SALTWATER FISHING ACCESS**

Recreational saltwater anglers are celebrating a new federal law changing how fisheries are managed.

Just before the new year, President Trump signed the Modernizing Recreational Fisheries Management Act of 2018, better known as the Modern Fish Act.

The act authorizes the use of management tools geared towards recreational fishing, and seeks out updated recreational harvest data. It will study mixed-use fishery allocation and provide recommendations on catch share management programs. The nation's estimated 11 million saltwater anglers could also see better public access to federal waters.

BoatUS, the nation's leading boat owners' group, applauds the act:

"What the act does for saltwater anglers is to update critical public policy to help ensure fisheries management and oversight also works for recreational anglers," said BoatUS Manager of Government Affairs David Kenney. A coalition of saltwater fishing advocates, including BoatUS and the National Marine Manufacturer's Association (NMMA) pushed for the measure.

"This is historic for the recreational boating and fishing community, capping years of hard work to responsibly modernize recreational saltwater fisheries management," said NMMA President Thom Dammrich.

The Environmental Defense Fund (EDF) notes how far the Modern Fish Act came as a compromise between recreational, commercial, charter/for-hire, and restaurant sectors, as well as many environmental groups .

"Over the course of the last year the Modern Fish Act has gone from a conservation threat to a bipartisan achievement... We can all be proud to have reached agreement on a bill that responds to the demands of recreational fishing advocates without jeopardizing either sustainability or Americans' access to local seafood," said Matt Tinning, Associate Vice President of EDF's Oceans Program.

Sponsors of the Modern Fish Act in Washington were Senator Roger Wicker (R-MS) and Congressman Garret Graves (R-LA), and key supporters Senators Bill Nelson (D-FL), Brian Schatz (D-HI), Roy Blunt (R-MO), Cory Booker (D-NJ), and Doug Jones (D-AL); and Congressmen Steve Scalise (R-LA), Rob Bishop (R-UT), Marc Veasey (D-TX), Rob Wittman (R-VA), Gene Green (D-TX), Daniel Webster (R-FL), and Austin Scott (R-GA).

*Bay Bulletin's* own outdoor sporting expert, Captain Chris Dollar, feels it's positive news on the Bay, too.

"The Modern Fish Act is a crucial step forward in helping bring federal fisheries management into the 21st Century. The law, which has been more than a dozen years in the making, will protect the rights of recreational anglers for years to come, and although not perfect as there's still work to do on the conservation and sustainability front, the Act finally recognizes the importance of sport fishing to the American way of life and our economy."

## **COAST GUARD TO IMPROVE RESPONSE TO ON-WATER 911 CALLS**

Since boaters began bringing cell phones on the water, first responders have urged everyone to reach for their VHF radio first in an emergency. It's the only way to be sure of reaching the closest, most relevant rescue agency.

But a large number of recreational boaters use cell phones to call 911, even if the call might not be routed correctly, and the caller risks being passed from agency to agency before getting help.

Now, to catch up with the times, the Coast Guard's procedures are going to be under review to fix that problem. A provision in the recently-passed Frank LoBiondo Coast Guard Authorization of Act of 2018 requires the Coast Guard to "formulate a national maritime Public Safety Answering Points (PSAP) policy."

PSAPs are local call centers that are manned 24/7 with trained dispatchers that receive 911 calls and route them to the proper emergency service. There are currently more than 6,000 in the U.S.

"This effort will help minimize the possibility of maritime calls being improperly routed and to assure the U.S. Coast Guard is able to effectively carry out its maritime search-and-rescue mission," said Tina Cardone, executive director of the Conference of Professional Operators for Response Towing (C-PORT). C-PORT was among the advocates that pushed for the legislation.

Boaters and anglers "have too much faith in [cell phones] as the sole means of communication on the water, especially in emergency situations," U.S. Coast Guard Petty Officer First-Class John D. Miller writes. Miller gives the example of a headboat owner who drowned in the Delaware Bay two years ago. Miller says the victim waited too long to call for help on his VHF radio, and finally reached out to authorities on his cell phone, as the boat sunk in 37-degree water. Miller says the time it took to pass the key information to the right responder may have contributed to the man's death.

In fact, locating a cell signal can be very involved, Miller writes. "We don't have that capability in our command centers, and that information is not easily obtainable from the cell phone companies — if they do have it — because of privacy concerns. All this research takes time, and during this process, things are happening on the water."

As the Coast Guard works to improve the system, BoatUS, the nation's leading advocate for recreational boaters reminds everyone to have a working VHS radio on board, and not to rely on a cell phone alone.


