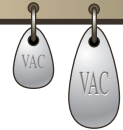
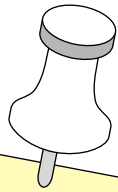

**SCALE CERTIFICATION
COMING UP AT FEBRUARY
MEMBERSHIP MEETING**

**LICENSE FEES CUT FOR LONGER
PERIOD LICENSES**

The Virginia Department of Game and Inland Fisheries introduced on January 1, 2012, options for reduced pricing for resident annual hunting, trapping and freshwater fishing licenses valid for two, three and four year periods. **DON'T FORGET – FORTY-TWO NEW FRESHWATER
RECORD SLOTS JUST OPENED**

Approval of the new Fresh Water species SUNFISH AND SUNFISH RED EAR and their basic weights has opened forty-two new opportunities for VAC Members to become club record holders. As you plan your angling activities for 2012, you may want to do a little tactical angling and become the "Owner" of one of these club records. Ownership of one of these records is not guaranteed to be permanent. The equipment needed is not complicated and the related angling techniques are not to master.

The revised Freshwater and Saltwater Basic Weights are now posted in the Member's Area of the VAC Website, www.virginiaanglersclub.org. Enter the Member's Area and click on "Basic Weights, Freshwater or Basic Weights, Saltwater. If you want to print down the Basic Weight Sheets, use the print Icon that is at the bottom of the screen.

These record sheets and basic weight sheets may also be downloaded to your computer.

Note: VAC Club Records sheets are not up dated as each card is received or as each Record is recognized. Updates are made in batches to make the task fit the time the record keepers have available for this work. CHECK GENERAL ASSEMBLY ACTIONS IMPACTING ANGLERS

The General Assembly is in Session now and will be considering many bills that will affect sportsmen and women in some way or another. There are three links found on page 6 of this issue of The Angler that you might want to check out. The links take you to information about bills of interest to sportsmen (content, sponsors, movement of the bills, thru the General Assembly, etc.).

One link lets you find out who your Delegate or Senator is and how to reach that person by phone, mail or e-mail.

A blank e-mail addressed to the Delegate or Senator selected will come up if you click the words "more about" that are at the bottom of the first column of information about the person selected. An e-mail is a very quick and effective way to get your opinions and advice to your Delegate or Senator.

HYPOTHERMIA IS LURKING DURING WINTER ANGLING

No one angling during cold weather is totally safe from hypothermia, a potential life threatening condition if you do not protect yourself from the cold or situations that could get you into a hypothermic state. Good advice about how to dress properly in cold weather and how to treat hypothermia can be found on page 8 of this issue of The Angler.

CATCHY COMMENTS

The 2012 saltwater fishing has started off with a phenomenal Striper season. The warm winter weather has kept the bay water temperatures higher than in past years and thus has helped to create a great Striper season. The fish are still around the bridge tunnel and off Rudee Inlet. A total of four saltwater Club Records have been set to date. This number of club records has surpassed previous years for the month of January.

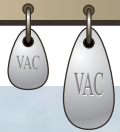
Dr. Mickey Kodroff has started off the new club year with several entries. While fishing South Lake in North Carolina, **Mickey** submitted a 10.5 pound Crappie on 2# spin and a 1 pound, 4 ounce White Perch on jigs. The Perch is worth 328 points, leads the spin division, and will be tough to beat this year. Another worthwhile catch was submitted in the middle of December when **Mickey** was fishing off Oregon Inlet and landed an 11 pound Bluefish on 12# plug. This entry will probably hold up well this year since there were no Bluefish entries for last year!

Charlie Fasano had a variety of entries fishing the Chesapeake Bay on December 11th. He first landed a 30 pound Striper on 20# line for 157 points. Later, he caught a Tautog on crab for his "angler rating"; and in the afternoon using jerk bait, **Charlie** landed a 2 pound, 8 ounce, Spotted Seatrout on 6# line for an even 100 points. It's a great day of fishing when you can get three entries!

Fred Cousins is again making a run for all the "pewter" and "silver" this year. He has upped his earlier Chain Pickerel entry with a 3 pound, 1 ounce, fish on 2# spin for 306 points. **Fred** also entered a 3 pound, 6 ounce, Largemouth Bass on spinner bait worth 225 points for his freshwater catches. While fishing with **Victor Skakandy**, **Fred** had a saltwater entry for a 21 pound, 12 ounce, Striper on 4# general fishing for 362 points. But, the nicest catch so far this year for **Fred** is his 8 pound, 6 ounce, Spotted Seatrout on 2# spin from the Elizabeth River. This 558 point entry leads the "spin division" and is the new Club Record for 2# spin. Not a bad start.

Striped Bass catches will complete the remainder of the entries for this newsletter. **Leroy Houser** will again lead the "heaviest category" for Striped Bass this year. Several days before Christmas, while fishing with **Gary Martel**, **Leroy** landed a 45 pound fish in the Chesapeake Bay using an eel for bait. The 48" Striper is a new Club Record for 16# line.

Parks Rountrey, **Bruce Henderson**, and **Fred Cousins** had chartered **Toney Horsley** and landed several nice Striped Bass on December 20th. **Parks** landed a 33 pound, 8 ounce, fish on 8# general worth 372 points off Kiptopeke Beach and **Bruce**, using 6# line, landed a 30 pound Striper worth 400 points. Both were using eels for bait that day.

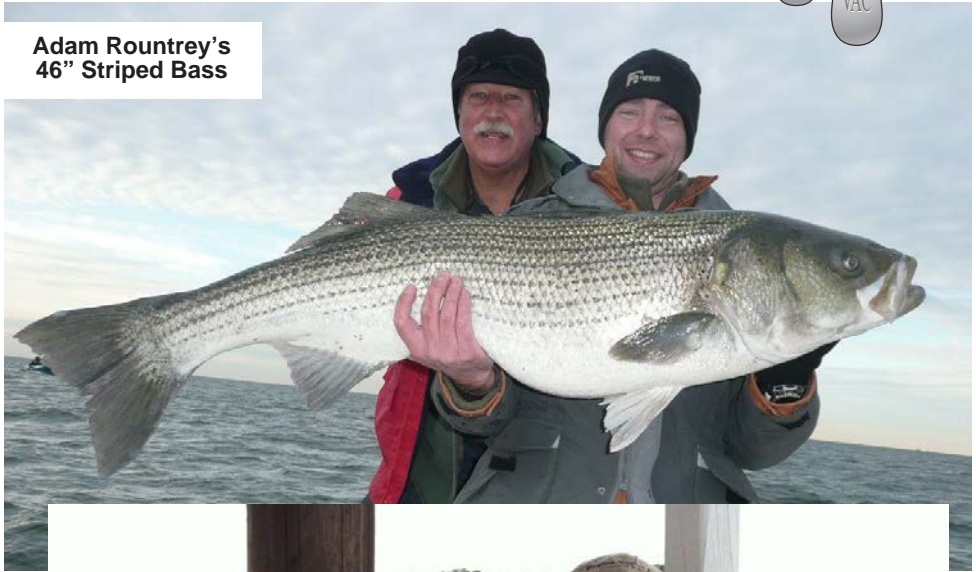


New member, **Andy Campbell**, entered the first “fly” entry for the year. **Andy** was fishing the York River using a “half & half” fly and landed a 26 pound, 8 ounce, Striper on 12# tippet. The fish will lead the “fly division” and will also be a new Club Record. The Striper is worth 331 points.

Last, but not least, **Jim Sheffield** was fishing the Eastern Shore on the last day of the inshore season and caught a 42 pound Striper on 6# general for the Club Record. The catch is worth 560 points and leads the “general division”. The most significant part about the newest record is that **Jim** currently holds the 2#, 4#, 6#, and 8# general category Club Records. The 2 and 4 pound catches are also line class IGFA World Records. That adds up to a lot of “cold and wet days” on the Chesapeake Bay!

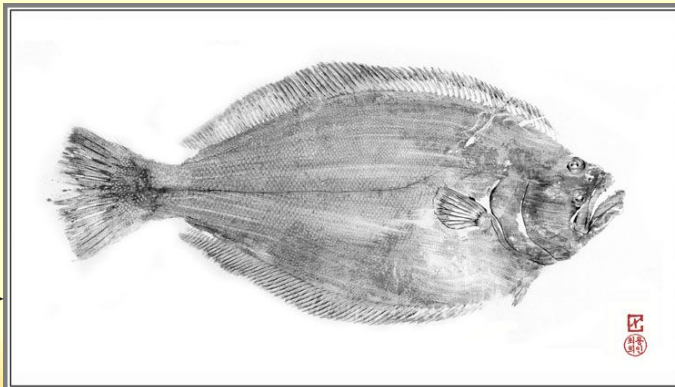

SCALE CERTIFICATION COMING UP IN FEBRUARY

- Write your name on the outside of the bag.
- Leave your bagged scales on the certification team's table.

GOVERNOR MCDONNELL ANNOUNCES DMV AND DGIF PARTNERSHIP

Joint Venture to improve One-Stop Shopping Options for Customers

Governor Bob McDonnell has announced a partnership between the Virginia Department of Motor Vehicles (DMV) and the Virginia Department of Game and Inland Fisheries (DGIF) that supports his government reform initiative to streamline services. Beginning in late-January, citizens can register boats and boat trailers in one trip to either DGIF or DMV. They will also be able to purchase hunting and fishing licenses from both agencies.

Speaking about the partnership, Governor McDonnell commented, "This partnership will simplify the citizens' interaction with state agencies. Boat-owners can choose where they go to register boats and boat trailers. Previously, boat-owners had to go to DGIF to register their boats and to DMV to register their trailers. Now, it's one-stop shopping. They can conduct both transactions at either agency."

Governor McDonnell continued, "The 74 local DMV customer service centers and two mobile offices will join the more than 700 DGIF license agents across the state so customers will not have to travel far to obtain these products if they desire a face-to-face experience."

DMV and DGIF are working with the Department of Conservation and Recreation (DCR) to determine how the DMV 2 Go mobile offices can assist with the sales of hunting and fishing licenses during peak seasons and events such as the highly-anticipated opening day for trout at Douthat State Park in early April.

Increased Options and Decreased Costs Available For Hunting, Trapping and Freshwater Fishing Licenses

Multi-year license discount goes into effect January 1, 2012

The Virginia Department of Game and Inland Fisheries (VDGIF) will introduce reduced pricing for resident annual hunting, trapping and freshwater fishing licenses for two-, three- and four-year periods beginning January 1, 2012. Purchasers will save \$2 for each additional year over the first since the license price is reduced \$1 and the associated \$1 license agent fee will be saved.

Multi-year licenses will only apply to three RESIDENT licenses (the annual Basic Hunting, Trapping and Freshwater Fishing Licenses) during this pilot program. VDGIF Chief Operating Officer Matt Koch said, "We are excited to offer this new option to our customers who have told us that this will be a convenience for them and save them money. Once the success of this pilot program is proven, the Department will consider expanding the multi-year offer to more licenses." Cost for one year of an annual resident basic hunting or freshwater fishing license is \$23; two years will be \$44; three years will be \$65; and four years will be \$86. Cost for the resident trapping license for one year is \$46; two years will be \$90; three years will be \$134; and four years will be \$178.

Licenses can be purchased at , by calling 1-866-721-6911 during business hours, or at any . VDGIF has a network of more than 700 license agents statewide at most sporting goods stores and bait shops.

PREVENTING FROSTBITE AND HYPOTHERMIA

Prolonged exposure to low temperatures, wind or moisture—whether it be) on a ski slope or in a stranded car—can result in cold-related illnesses such as frostbite and hypothermia. The National Safety Council offers this information to help you spot and put a halt to these winter hazards.

Frostbite is the most common injury resulting from exposure to severe cold. Superficial frostbite is characterized by white, waxy, or grayish-yellow patches on the affected areas. The skin feels cold and numb. The skin surface feels stiff but underlying tissue feels soft and pliable when depressed. Treat superficial frostbite by taking the victim inside immediately. Remove any constrictive clothing items that could impair circulation. If you notice signs of frostbite, immediately seek medical attention. Re-warming usually takes 20 to 40 minutes or until tissues soften.

Hypothermia occurs when the body's temperature drops below 95 degrees Fahrenheit. Symptoms of this condition include change in mental status, uncontrollable shivering, cool abdomen and a low core body temperature. Severe hypothermia may produce rigid muscles, dark and puffy skin, irregular heart and respiratory rates, and unconsciousness.

Treat hypothermia by protecting the victim from further heat loss and calling for immediate medical attention. Get the victim out of the cold. Add insulation such as blankets, pillows, towels or newspapers beneath and around the victim. Be sure to cover the victim's head. Replace wet clothing with dry clothing. Handle the victim gently because rough handling can cause cardiac arrest. Keep the victim in a horizontal (flat) position. Give artificial respiration or CPR (if you are trained) as necessary.

How to prevent cold-related illnesses

Avoid frostbite and hypothermia when you are exposed to cold temperatures by wearing layered clothing, eating a well-balanced diet, and drinking warm, non-alcoholic, caffeine-free liquids to maintain fluid levels. Avoid becoming wet, as wet clothing loses 90 percent of its insulating value.

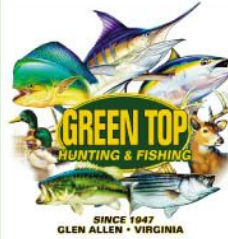
